## Virgin Atlantic VSbulletin 003

We need to let you know effective from 1 July 2017, a Goods and Service Tax (GST) will be applicable on all tickets for flights that are originating from India.

- Bookings ticketed before 01 July 2017 will not be subject to the GST tax.
- Bookings ticketed on or after 01 July 2017 will be required to pay. This will also apply to any amendments made after this date.
- GST will be applicable as follows:

Cabin	Tax applicable
Economy cabin, domestic & international	5% of the base fare plus YQ/YR
Premium or Upper Class cabin, domestic & international	12% of the base fare plus YQ/YR

- Customers travelling for business purposes will be able to claim the tax back after travel.
- If customers are travelling for business, they must register with the India authorities to obtain their GST number.

- For customers travelling on business the below SSR's will be required.
- The SSR information is required within 15 days of ticket issue or date of final segment, whichever is earlier. If outside of this period, the business will be unable to claim the tax back.
- The SSR information is unable to be added post departure.
